- Chairperson Report Danielle Aubin
 Danielle welcomed attendees to the first official parent council meeting of the school year, and shared highlights from of parent council activities from the previous year.
- 7. Administrative report Keith van deer Meer and Carlie Ramotowski
 - Mapping the Trail will take place on October 19 this new approach is a pilot project.
 - Parents will be asked to complete an exit survey.
 - Report cards will no longer have narrative comments from teachers. The Mapping the

- 1. Meeting was called to order at 7:49 PM.

- 2. Motion to approve the agenda: Leah/Margaretha. CARRIED
- 3. Motion to approve the minutes from June 7, 2023: Leah/Margaretha. CARRIED
- 4. Treasurer Report Margaretha Hallett
 - Margaretha reviewed the P&L and balance sheet.
 - Cheque for playground equipment needs to be given to the school.
 - Quite a few outstanding cheques.
 - Based on proposed initiatives, fundraising will need to be undertaken to fulfill the asks from the school, and things that parent council hope to do.
- 5. Playground Update: The playground grant writing was successful and a grant has been awarded to cover the cost of finishing the resurfacing of the playground scheduled for spring.
- 6. Hot Lunch: Hot lunches for the year have been planned with some new vendors to try.
 - Things went smoothly with Pita Pit and feedback has been good.
 - Will remind parents of the option to donate a lunch throughout the year.
 - The students who receive these lunches are rotated, so each student on the list has a chance to enjoy a special lunch from time to time.
 - With the cost of hot lunch increasing, many families are not ordering every time, so these students do not stand out, and have access to other food supports as well.
- 7. Kernels Popcorn Fridays/Booster Juice: Grade levels have two different break times on Fridays will ask for Booster Juice to be delivered for 9:45 in time for the first break.
- 8. Upcoming Initiatives/Fundraising:
 - In place of the Danceathon, the school will be organizing an ABC fundraiser for extra field trips.
 - Other initiatives that were mentioned include:
 - Ice cream prize for the ABC fundraiser, winter event (TBD), Motivational Magic, teacher appreciation supper, spring concert rental, pancake breakfast and end-of-year Kona Ice, and contributing to the outdoor learning space.
 - Parents indicated last year that opportunities to engage in learning about indigenous cultures are important – over summer parent council voted to support the purchase of Nitsitapii landscape installations from the Galt Museum.
 - Sara will prepare a land acknowledgement to include at parent council/society meetings.
 - Sara asked about funding class pictures for all students since Lifetouch no longer includes them free of charge. Keith will inquire about this with Mark Orenstein from Lifetouch.
 - Initiatives can be finalized during the budget meeting.

- d) Pizza night Two Guys a portion of sales using promo code PROBE donated back to school. Was successful in previous years. Fundraisers like this often go over better with our parent community some families prefer not to sell anything.
- e) Spring Market went fairly well last year (the first year). Domesticated Divas donated services and table fees back to the school. Would have to inquire if she would be able to offer us a spot again this year.
- f) Fundscrip Giftcards Need to market strongly and early to families. We can accept e-transfer this year, which may be more convenient. Communicate that cards can be purchased for everyday shopping like groceries and gas, and can be purchased online all year long.
